WHEREAS, on January 24, 1998, the Board of Trustees of the Sweetwater Union High School District ("Governing Board") adopted Resolution No. 2639 to thereby form Community Facilities District No. 10 of the Sweetwater Union High School District ("CFD No. 10") in accordance with the Mello-Roos Community Facilities Act of 1982, as amended ("Mello-Roos Act"), and to authorize the levy by CFD No. 10 of special taxes on property within the boundaries of CFD No. 10 ("Special Taxes"); and

WHEREAS, CWC Broadway CV 256, LLC ("Property Owner") requested that the District annex, to CFD No. 10, certain property owned by the Property Owner ("Proposed Annexation Territory"); and

WHEREAS, on May 13, 2024, the Governing Board adopted Resolution No. 4903 to thereby: (i) declare its intention to annex the Proposed Annexation Territory to CFD No. 10; (ii) to approve a map of the boundaries of the Proposed Annexation Territory ("Boundary Map") and to direct that the Boundary Map be recorded in the official records of San Diego County; (Iii) to set forth a description of the CFD Facilities to be financed and/or acquired using the Special Taxes to be levied on the Proposed Annexation Territory; and (iv) to set forth a copy of the RMA; and

WHEREAS, on June 24, 2024, the Governing Board conducted and completed a noticed public hearing regarding the proposed annexation of the Proposed Annexation Territory to CFD No. 10 and the proposed levy of Special Taxes on the Proposed Annexation Territory to pay for and/or finance school and related facilities ("CFD Facilities") and other costs of CFD No. 10; and

WHEREAS, subsequent to the June 24, 2024, public hearing, the Governing Board adopted Resolution No. 4911 to thereby call an election to be conducted within the Proposed Annexation Territory regarding the proposition to authorize the levy of Special Taxes on the Proposed Annexation Territory ("Proposition 2024-A"); and

WHEREAS, thereafter on June 24, 2024, an election was held within the Proposed Annexation Territory ("Election"), at which the eligible voters approved Proposition 2024-A; and

WHEREAS, on June 24, 2024, following the Election, the Governing Board adopted Resolution No. 4912 to thereby annex the Proposed Annexation Territory to CFD No. 10; and

NOW, THEREFORE, the Governing Board of the Sweetwater Union High School District, acting as the Legislative Body of CFD No. 10, does hereby ordain as follows:

Section 1. The foregoing recitals are all true and correct, and the Governing Board hereby adopts such recitals as findings of the Governing Board.

Section 2. By enacting this Ordinance No. 25 ("Ordinance"), the Governing Board hereby authorizes the levy of Special Taxes of CFD No. 10 on the property within the Proposed Annexation Territory, pursuant to that certain "Rate and Method of Apportionment of Special Tax – Community Facilities District No. 10 – Sweetwater Union High School District" ("RMA"), a copy of which is set forth in Ex-"A" attached hereto, and in such amounts as may be necessary to pay for and/or finance CFD Facilities and related obligations.

Section 3. The Governing Board is hereby authorized to determine each year, by resolution, the rate and amounts of the Special Taxes to be levied on property within the Proposed Annexation Territory, and such rates and amounts to be levied in subsequent fiscal years; provided that the Special Tax rates shall not exceed the rates determined in accordance with the RMA.

Section 4. To the extent provided in the RMA, properties or entities of the state, federal, or other local governments within CFD No. 10 shall be exempt from the levy of Special Taxes of CFD No. 10, except that, notwithstanding the foregoing, when property within CFD No. 10 not otherwise exempt from such Special Taxes is acquired by a public entity through a negotiated transaction, or by gift or devise, the Special Taxes shall continue to be levied on such property and shall be enforceable against the public entity that acquired the property.

Section 5. No other properties within CFD No. 10 or entities owning property within CFD No. 10 are exempt from the levy of Special Taxes of CFD No. 10 unless the properties or entities are expressly exempted by applicable law. Resolution No. 4903. or the RMA.

Section 6. All of the Special Taxes collected pursuant to this Ordinance shall be used consistent with the Mello-Roos Act Resolution No. 4903, and Resolution No. 4911

Section 7. The Special Taxes authorized pursuant to this Ordinance may be collected in the same manner as ordinary ad valorem taxes are collected and may be subject to the same penalties and the same procedure, sale, and lien priority in cases of delinquency as provided for ad valorem taxes, or another procedure as may be adopted or authorized by the Governing Board.

Section 8. The San Diego County Treasurer-Tax Collector may deduct reasonable administration costs incurred in collecting the Special Taxes authorized pursuant to this Ordinance.

Section 9. Without limiting any other remedies, if any amount levied pursuant to this Ordinance in whole or in part as Special Taxes required for payment of bond interest or principal, together with any penalties and other charges accruing in accordance with this Ordinance, are not paid when due, the Governing Board may bring an action to foreclose such lien not later than four years after the due date of the last installment of principal.

Section 10. This Ordinance relating to the levy of Special Taxes by CFD No. 10 shall take effect thirty days after enactment by the Governing Board.
